with CBSE board and the school is taking less fees than the other teaching institutes with same board situated in same area. It is also submitted by the authorized persons of the school that school has spent Rs. 1,07,83,418/- in the year 2022-23 and projected Rs. 1,18,61,760/- and in the year 2023-24 under the head of Salary for the staff of the School, which is also confirmed in Audited and Projected Income Expenditure Accounts for the same year.

10. At last, authorized person of the school requested before the committee to allow 7 % increase in fees for all three years individually and also undertake that school will not take term fees from the students. Considering above facts this committee determine fees as under:
